("Aranda"), 3,446,187 Preferential Offering Shares and to Breedens Investments Pte. Ltd. ("Breedens"), 109,680,093 Shares comprising 6,115,000 Placement Shares, 9,157,093 Preferential Offering Shares and 94,408,000 Subscription Shares.</p> <p>Accordingly, the direct interests of Aranda and Breedens in Olam has increased to 15.99% as at 11 July 2011.</p> <p>Aranda and Breedens are subsidiaries of Seletar which is a subsidiary of Temasek Capital. Hence, the deemed interests of Seletar and Temasek Capital (through Aranda's and Breedens' direct shareholding) has increased to 15.99% as at 11 July 2011.</p>
