On 30 September 2011, DBS Group Holdings Limited ("DBS"), an associated company of Temasek Holdings (Private) Limited ("Temasek"), completed the sale of 100% of DBS Asset Management Limited ("DBSAM"). Accordingly, Temasek ceased to have any deemed interest through DBSAM in the ordinary shares in Olam International Limited ("Shares").

The completion of the sale of DBSAM, when combined with the series of dealings in Shares by DBS subsidiaries on and before 30 September 2011, caused Temasek's interest to fall to 390,437,283 Shares (**15.99%) comprising:

- (i) 79,262,313 Shares (**3.25%) held by Aranda Investments Pte. Ltd., an indirect wholly owned subsidiary of Temasek;
- (ii) 311,136,140 Shares (**12.74%) held by Breedens Investments Pte. Ltd., an indirect wholly owned subsidiary of Temasek; and
- (iii) 38,830 Shares (less than **0.01%) held by DBS subsidiaries.

Temasek became aware of the change in the percentage level of its interest in the Shares on 3 October 2011.
