**Details of transactions and events giving rise to relevant event**

On 6 August 2010 Olam International Limited ("**Olam**") made a full cash takeover offer under the Takeovers Code to acquire all of the ordinary shares in NZ Farming Systems Uruguay Limited ("**NZS**") that it did not already hold or control ("**the Offer**").

During the period between 24 September 2010 and 27 September 2010 ("**Event Period**"), Olam received acceptances under the Offer from various NZS shareholders which have resulted in a movement of 1% or more in the relevant interest Olam has in shares in NZS. During the Event Period, Olam received acceptances under the Offer from NZS shareholders in respect of an aggregate of 26,643,591 ordinary shares for aggregate consideration of \$18,650,513.70 (representing a price of \$0.70 cents per share, being the offer price per share set out in notice of variation to the Offer dated 24 August 2010).

The Offer has now closed, and transfers have also been registered in respect of accepting NZS shareholders, resulting in a change in nature of Olam's interest.
