**Footnotes**

483,493,065 Ordinary Shares in Olam International Limited are held by Kewalram Singapore Limited ("Kewalram") and Kewalram is a wholly-owned subsidiary of CACL, which in turn is a wholly-owned subsidiary of KCH.

CACL and KCH are therefore deemed to be interested in the 483,493,065 Ordinary Shares held by Kewalram.

The GKC Settlement, Hariom Trust, the DKC Settlement and Investec Trustees (Jersey) Ltd as trustee of PKC 2008 Settlement ("PKC 2008 Settlement") are shareholders of KCH, each holding approximately 29%, 28%, 28% and 15% respectively in the issued and paid-up capital of KCH. Pursuant to Section 7(4A) of the Companies Act, as the GKC Settlement, Hariom Trust and the DKC Settlement are associates of the PKC 2008 Settlement and vice versa, the 2008 PKC Settlement would be deemed to be interested in the shares held by Kewalram.

The GKC Settlement, Hariom Trust, the DKC Settlement and the PKC 2008 Settlement are therefore deemed to be interested in the 483,493,065 Ordinary Shares held by Kewalram in the Company.

The percentage of issued share capital after the change is calculated based on 2,392,713,869 shares (excluding treasury shares) in issue as at 25 June 2012.
