Each of OHL, OWL and Rhone trustees as trustee of the Orbis Holding Trust is a substantial shareholder of the Company by virtue of its deemed interest in the shares managed by its subsidiaries, Orbis Investment Management Limited and Orbis Investment Management B.V.I. Limited, as fund managers of the Orbis funds. Each such fund manager has the ability to vote and acquire/dispose of the Company's shares for and on behalf of the Orbis funds. In addition, Rhone trustees as trustee of the Orbis Trust is also a substantial shareholder of the Company by virtue of being entitled to exercise or control the exercise of not less than 20% of the votes attached to the voting shares of OHL. Separately, Orbis Asset Management Limited as fund manager for another Orbis fund holds a deemed interest of less than 0.001% in the Company's shares by having the ability to vote and acquire/dispose of the Company's shares for and on behalf of this Orbis fund.

Percentages of shareholdings stated in Parts II, III and IV (as applicable) of this Notice are calculated based on the total number of issued ordinary shares (excluding treasury shares) being 2,437,488,869 as at 12 June 2012.
