On 8 June 2012, Olam International Limited ("Olam") announced that it had repurchased 3,183,000 ordinary shares which caused the number of its issued ordinary shares excluding treasury shares to decrease to 2,439,226,869 ordinary shares. This caused a change in the percentage level of Temasek Capital's and Seletar's deemed interest in Olam from 15.99% to 16.01% comprising:-

1. 79,262,313 ordinary shares held by Aranda Investments Pte. Ltd. ("Aranda"); and

2. 311,136,140 ordinary shares held by Breedens Investments Pte. Ltd. ("Breedens").

Aranda and Breedens are subsidiaries of Seletar which is a subsidiary of Temasek Capital.

Temasek Capital and Seletar became aware of the change in the percentage level of their respective deemed interest in Olam on 11 June 2012.
