Following the transaction which is the subject of this notification, Temasek Capital (Private) Limited ("Temasek Capital") has a deemed interest in 525,847,453 voting shares of the Listed Issuer (representing approximately 22% of the issued voting shares of the Listed Issuer) comprising (i) a continued deemed interest in 525,842,453 voting shares in which Seletar Investments Pte Ltd ("Seletar") has a deemed interest and (ii) a new deemed interest in 5,000 voting shares acquired by Aranda Investments Pte. Ltd. ("Aranda") and which are the subject of this notification.

Temasek Capital has a controlling interest in Seletar which, in turn, has a controlling interest in each of Aranda and Breedens Investments Pte. Ltd. ("Breedens"). Aranda holds an aggregate of 166,888,313 voting shares of the Listed Issuer and Breedens holds an aggregate of 358,959,140 voting shares of the Listed Issuer.

Temasek Capital is therefore deemed, pursuant to section 4(4) of the Securities and Futures Act, to have an interest in the 525,847,453 voting shares of the Listed Issuer (representing approximately 22% of the issued voting shares of the Listed Issuer) in which Seletar is deemed to have an interest.
