Payment of interest on each Bond will be made by transfer to the registered account of the bondholder or by US dollar cheque drawn on a bank in New York mailed to the registered address of the bondholder if it does not have a registered account.

Bondholders shall not be entitled to any interest or other payment for any delay in their receipt of the interest payment.
