ProClass is the largest independent cotton testing and classing house in Australia. Consequent to the completion of the share acquisition, Olam Australia will change its cotton classing processes from being conducted in Brisbane to being conducted independently at the ProClass facility in Goondiwindi using the same state-of-the-art High Volume Instrument (HVI) classing system.
