Queensland Cotton Corporation, a wholly-owned subsidiary of the Company, has exercised its put option under a shareholders' deed dated 23 June 2014 to sell its remaining 20% stake in Agrex Australia Pty Ltd (previously known as Olam Grains Australia Pty Ltd) for a total cash consideration of US\$8.8 million. Following the disposal, Agrex Australia ceased to be an associated company of Olam.
