**RESTORATION OF FREE FLOAT**

Olam International Limited (the "**Company**") refers to its announcements dated 17 November 2017 and 27 February 2018 in relation to, *inter alia*, the free float of the Company.

The Company is required under Rule 723 of the Listing Manual of the Singapore Exchange Securities Trading Limited ("**Listing Manual**") to ensure that at least 10% of its ordinary shares in the capital of the Company<sup>1</sup> ("**Shares**") are in the hands of the public<sup>2</sup> ("**free float**").

The Company is pleased to update shareholders that the free float has today been restored to 10.27% following the vesting and release of Shares under certain subsisting restricted share awards and performance share awards (collectively, the "**Share Awards**") granted under the Olam Share Grant Plan, thereby satisfying the requirement under Rule 723 of the Listing Manual.

The Share Awards were granted under the Olam Share Grant Plan and announced on 7 April 2015, 15 April 2016, 24 April 2017 and 5 May 2017. A total of 11,039,277 Shares were released today, comprising 855,394 Shares released to non-public shareholders and 10,183,883 Shares released to public shareholders.
