The change in interest arises from the following:

(1) Vesting and release of the 317,600 performance share awards ("PSA") pursuant to the Olam Share Grant Plan ("OSGP"). The remaining 82,400 PSA not vested and released was cancelled; and

(2) Vesting and release of the 200,537 restricted share awards ("RSA") issued pursuant to the OSGP.

As at 2 April 2018, the total number of shares underlying the options/awards held after the change are as follows:

(a) 15,000,000 share options granted pursuant to the Olam Employee Share Option Scheme;

(b) 499,110 unvested RSA granted pursuant to the OSGP to be released according to the stipulated vesting periods;

(c) up to 410,000 PSA granted on 15 April 2016 pursuant to the OSGP. The actual number of shares to be delivered pursuant to the PSA granted will range from 0% to 192.5% of the base award and is contingent on the achievement of pre-determined targets set out in the three year performance period and other terms and conditions being met; and

(d) up to 392,147 PSA granted on 24 April 2017 pursuant to the OSGP. The actual number of shares to be delivered pursuant to the PSA granted will range from 0% to 200.0% of the base award and is contingent on the achievement of pre-determined targets set out in the three year performance period and other terms and conditions being met.
