ANNOUNCEMENT

SIAS-OLAM VIRTUAL INFORMATION SESSION

Olam International Limited (the “**Company**” or “**Olam**”) had on 14 December 2021 announced the proposed restructuring of the Company by way of a scheme of arrangement under Section 210 of the Companies Act 1967 (2020 Revised Edition) of Singapore (the “**Companies Act**”) (the “**Scheme**”), the proposed listing of OFI Group Limited, and the proposed demerger of the Olam Food Ingredients business (collectively the “**Proposed Transactions**”).

The Company has earlier today released to the shareholders of the Company (“**Olam Shareholders**”) the notices dated 27 January 2022 for each of the Scheme Meeting and the extraordinary general meeting of the Company (collectively, the “**Meetings**”) to be convened by electronic means for the purpose of seeking Olam Shareholders’ approval for the Proposed Transactions.

The Company, in conjunction with the Securities Investors Association (Singapore) (“**SIAS**”), has organised a Virtual Information Session (“**VIS**”) on the Proposed Transactions which will be held by the Company on **9 February 2022 at 7.00 p.m. Singapore time**. Olam Shareholders are cordially invited to participate in the VIS.

The session will be moderated by Mr. David Gerald, Founder, President and Chief Executive Officer of SIAS. Mr. Sunny George Verghese, the Executive Director, Co-founder and Group Chief Executive Officer of Olam, will be delivering a presentation on the Proposed Transactions, followed by a “live” Q&A session. Mr. Sunny George Verghese, Mr. Neelamani Muthukumar (Group Chief Financial Officer) and Mr. Shekhar Anantharaman (Chief Executive Officer of Olam Food Ingredients) will be present to address the questions from Olam Shareholders.

In view of the COVID-19 restriction orders in Singapore and the related safe distancing measures, the VIS will be conducted virtually via a “live” webcast.

Olam Shareholders can raise questions (if any) at the VIS during the “live” Q&A session.
