Ltd. ("SeaTown"). SeaTown is an independently-managed Temasek portfolio company. Temasek is not involved in its business or operating decisions, including those regarding its positions in Shares.

On 15 March 2022, Olam International Limited ("OIL") effected a scheme of arrangement (the "Scheme") pursuant to which all of the OIL shares were acquired by OFI Group Limited ("OFIG") in exchange for new shares to be allotted and issued in the capital of Olam Group Limited ("OG"). Pursuant to the terms of the Scheme, all the OIL shares held by Breedens, Aranda and SeaTown, have been acquired by OFIG. In exchange, Breedens, Aranda and SeaTown received 1,963,179,432 shares in the capital of OG, representing 51.08% of all of the issued OG shares.

Temasek's deemed interest arises from the interests in Shares held by Aranda, Breedens and SeaTown as follows:

(A) Temasek's interest through Breedens	41.7270%
(i) Breedens has a direct interest in 41.7270% of the Shares.	
(ii) Breedens is a wholly owned subsidiary of Seletar Investments Pte Ltd ("Seletar").
