#### Changes to Entities

- (i) Olam Agro Peru S.A.C. ("**Olam Peru**"), a wholly-owned subsidiary of the Company, had merged with its wholly-owned subsidiary, Olam Andina Peru S.A.C. ("**Olam Andina**"). Subsequent to the merger, Olam Andina (being the company absorbed by Olam Peru) was dissolved.
- (ii) Arise IZ Togo SAU, an associated company of the Company has been dissolved on 7 July 2020.

#### Divestment

Olam Peanut Shelling Company, Inc ("**Olam Peanut**"), an indirect subsidiary of the Company had on 1 September 2020 entered into an Amended & Restated Membership Interest Purchase Agreement with Escambia Peanut Company, LLC ("**Escambia**"), an associated company of the Company, to dispose of its entire 35.96% membership interest in Escambia for a total consideration of USD4,500,000 which was arrived at on a willing-buyer willing-seller basis. Following this, Escambia ceased to be an associated company of Olam Peanut and the Company.

The aforementioned changes are not expected to have any material impact on the earnings per share or net tangible assets per share of the Company for the financial year ended 31 December 2020.

None of the Company's directors and controlling shareholders has any interest, whether direct or indirect, in the above transactions (other than through their shareholdings in the Company).

This announcement excludes transactions which were separately announced during the second half of the financial year ended 31 December 2020.
