## PROPOSED DEMERGER OF THE OLAM AGRI BUSINESS OF OLAM GROUP LIMITED

## NOTICE OF COURT HEARING DATE TO APPROVE THE CAPITAL REDUCTION

## 1. Introduction

Olam Group Limited (the "Company") refers to:

- (a) the circular (the "Circular") released on 6 March 2023 to the shareholders of the Company ("Shareholders") to seek Shareholders' approval in relation to, among others, the proposed capital reduction exercise to be undertaken by the Company under Section 78G read with Section 78I of the Companies Act 1967 of Singapore ("Companies Act") to effect the proposed demerger of the Olam Agri business of OGL (the "Proposed OA Capital Reduction"); and
- (b) the announcement dated 29 March 2023 released by the Company in relation to, among other things, the approval of the Proposed OA Capital Reduction by the requisite majority of Shareholders at the Extraordinary General Meeting held on 29 March 2023.

Unless otherwise defined herein, words and expressions used in this announcement bear the meanings as ascribed to them in the Circular.

## 2. Notice of Court Hearing Date to Approve the Proposed OA Capital Reduction

The Company wishes to announce that:

- the Company has filed HC/OA 325/2023 in the High Court of the Republic of Singapore ("Court") to apply for an order to approve the Proposed OA Capital Reduction (the "Proposed OA Capital Reduction Court Order"); and
- (b) the said application has been fixed for hearing on 18 April 2023 at 10 a.m. (Singapore time) at the Supreme Court of Singapore.



Subject to the grant of the Proposed OA Capital Reduction Court Order, the Proposed OA Capital Reduction shall become effective and binding upon the lodgement of the Proposed OA Capital Reduction Court Order and a notice containing the reduction information with the Registrar of Companies.

Copies of the court application relating to HC/OA 325/2023 are available for inspection upon request during normal business hours at the registered office of the Company at 7 Straits View, Marina One East Tower, #20-01, Singapore 018936<sup>1</sup>, from the date hereof until (and including) 18 April 2023.
